 - a. Material Inward
 - b. Material Outward
 - c. Visitor
 - d. DG Regarding
 - e. Shelter Opening
 - f. Challan/Gate pass file
 - g. Occurrence / Handling taking over

SECURITY SHOULD BE RESPONSIBLE FOR THE FOLLOWING

1. He will be responsible for the paper security of all the assets lying at the site.
2. He will ensure proper access to the tower and generator for staff & associates of the principal employer.
3. He will responsible for cleanliness of shelter room & site area.
4. He will not allow anybody to enter into the site without valid/ authentic I-card. He shall verify it and request the visitors to enter their details in visitors register. This is mandatory.
